Activity

In April, Middleton Officers handled 1565 calls for service, 711 field initiated, 854 dispatched, issued 515 citations, made 37 criminal arrests and investigated 22 accidents.

In May, Middleton Officers handled 1791 calls for service, 839 field initiated, 952 dispatched, issued 499 citations, made 28 criminal arrests and investigated 31 accidents.

Police stopped the vehicle and one passenger fled on foot. Police recovered the DVD player from Ace Hardware, as well as another stolen one from the nearby CVS Pharmacy. TRAFFIC ENFORCEMENT ACTIVITIES

During the month of May there were a total of 47 traffic accidents of which 17 were in parking lots. This compares to 38 accidents in May 2008.

During the month of May, the national annual Click-It-Or-Ticket campaign was underway. During the month, 143 seatbelt citations of all kinds were issued, 92 of those citations were written during the 18th to 31st campaign dates. The pre-campaign days saw 3.0 citations per day while the campaign days saw 6.8 per day.

Officer Mike Wood began part-time patrol on the Department motorcycle. Media coverage of the new patrol method was seen on television, The Wisconsin State Journal and Middleton Times-Tribune. Within the first hour on motor patrol, Officer Wood handled a traffic accident on Century Avenue and issued the first citation from the motorcycle's computer.

Two patrols were done for our OWI grant. Fourteen stops were made. Nine warnings were issued. Citations were: OWI two, OAR one, Speed one, Failure to Obey Sign one, Equipment one and one miscellaneous.

Regular shift directed traffic patrols were performed on first shift on 13 days and on 11 days by second shift for a total of 92 hours. Streets addressed were: Allen Blvd, Hwy Q, Hwy 12, Cayuga/Elmwood, Century Avenue, Discovery Drive, Fortune Drive, Greenway Station area, Maywood Avenue, Old Middleton Road, N Gammon Road, N High Point Road, Park Street, Parmenter Street, Pheasant Branch Road, Pleasant View Road, and Stonefield/Boundary.

Regular shift directed patrols resulted in 144 enforcement actions of which: 28 warnings for Speed and 59 citations, 17 citations for Non-seatbelt use, 17 warnings and one citation for various Registration violations, two warnings for Failure to Obey Sign and seven citations, two citations for OAR, three citations for various Driver's License violations, four warnings for Failure to Yield, one warning for U-turn, one equipment warning, one citation for Disorderly Conduct with Motor Vehicle and one warrant served.

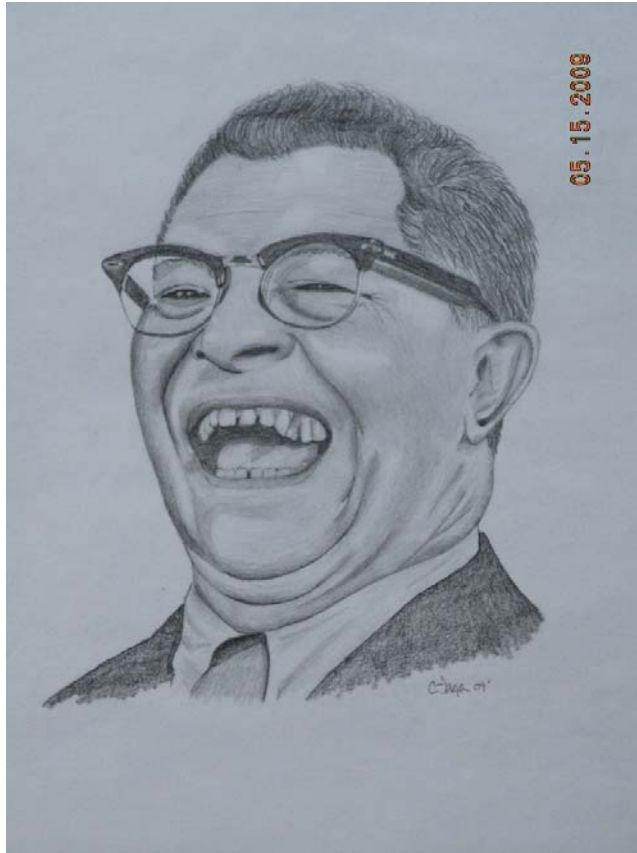

INVESTIGATIVE UNIT REPORT

Regardless of the time of year or status of the economy, financial crimes are a staple on the menu for members of the Middleton Police Department's investigative team. May of 2009, was no exception to this rule.

The issuance of worthless checks (IWC), employee theft and identity theft are the three most frequently reported financial crimes. Of the 12 fraud investigations assigned during the month of May, two were employee thefts, two were credit card fraud cases and the remaining eight were IWC cases.

In early May, members of the Middleton ISB met with the controller and general manager for the new Costco store in Middleton. As a result of these meetings, Costco brought forth over 50 worthless check cases that they had been the victim of since their opening. Upon review of each of these case files, it was determined that only six criminal investigations could be pursued. As of the writing of this document, all but one

of these investigations have been resolved by payment in full to Costco or criminal charges being filed against the perpetrator.

SCHOOL LIAISON OFFICER REPORT

Middleton High School

The month of May was busier than the last few months as the new SRO, Travis Kakuske, stepped into the position. Besides the monthly meetings, we were kept busy with a total of 45 calls for service between the two of us, with Travis taking most of those.

The calls we took included eight thefts, seven property lost, six disturbances, four property found, three status offenses, three follow up, two threats, two check person, and one each of 911 disconnect, assist citizen, fire alarm, assist other department, annoying phone call, damage to property, information, malicious mischief, sexual conduct, and controlled substance.

These calls resulted in a total of six citations and four criminal arrest referrals. That included three citations for truancy, one for carrying a concealed weapon, one for damage

to property, and one for theft. The criminal referrals were for theft, battery to a school district employee, resisting an officer, and disorderly conduct.

Kromrey Middle School

May's call activity was very high. During May, I trained Officer Sherry for two weeks. Officer Sherry will be the School Liaison Officer at Kromrey Middle School next school year.

At the elementary school level, Matt Sherry and I did nine presentations to students on tobacco, alcohol and drug awareness at Sauk Trail. We also went into all elementary classes at Northside and Sauk Trail to speak about summer safety and keeping safe.

During May, I attended the weekly building consultation team meeting, the bi-weekly attendance meeting, the monthly Dane County School Resource Officer meeting and a peer court meeting.

Also during May, I organized training for all Para-educators on Gang awareness. This was presented by a Dane County Deputy.

In May and the first two weeks of June, there were 15 documented calls for service. These included three disturbances, one theft, three follow ups, two information calls, two uniform controlled substance calls, two assist citizens, one EMS call and three code enforcement calls for service.

I issued one citation for possession of marijuana, one state charge of possession of marijuana, one state charge of possession of paraphernalia, one citation for selling alcohol to an underage person and four citations for disorderly conduct.

During this time, Officer Sherry also issued two citations for disorderly conduct and two citations for unauthorized use of a computer.

During the last week of school, the Kromrey students ended their year with field trips that were very successful. I helped to supervise the eighth grade graduation and dance which ended another great year at Kromrey Middle School.
